# **SRDC unveils Regional Trail Plan**

The Southwest Regional Development Commission (SRDC) recently announced the launch of a comprehensive regional trail plan designed to strengthen support for trails across Southwest Minnesota. This initiative aims to enhance equitable access to recreational funding, boost tourism, attract and retain residents, and foster collaboration among local trail organizations.

The primary objective of the Southwest Regional Trails Plan is to develop a cohesive vision for the region's trail network, elevating awareness of outdoor recreation while building upon the successes of local trail organizations. By creating an integrated trail system, the plan is expected to significantly boost

SRIC tourism, stimulating growth in local businesses and job opportunities to accommodate visitors.

"This plan represents a significant step forward in connecting our communities and enhancing the quality of life in Southwest Minnesota," said SRDC Community Development Director, Jason Walker. "We are committed to engaging trail users and local partners to promote outdoor recreation and tourism throughout our region."

# Luverne Receives \$180,000 for Storm Sewer Improvements

We're excited to announce that the City of Luverne has been awarded \$180,000 in Federal PROTECT funds for vital improvements to their storm sewer system! This funding comes from the Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportation (PROTECT) Formula Program, designed to enhance the resilience of our transportation infrastructure against future weather events and natural disasters.

City of Adrian has received a significant boost to its eco-

nomic infrastructure. The U.S. Department of Commerce awarded them a \$1.6 million grant to enhance electrical infrastructure, paving the way for increased business opportunities and job creation in the region.

This investment will fund the construction of a new electrical substation and essential equipment, ensuring reliable power for local businesses and supporting the creation or retention of over 175 jobs. Leaders from the Biden-Harris Administration, including Secretary of Commerce Gina Raimondo, emphasize the importance of this project for the future economic growth of Adrian.

As Adrian continues to develop its vibrant business community, this funding represents a crucial step toward modernizing its electrical grid. With the support of local funds, this project promises to strengthen the community's resilience and economic prospects for years to come.

## United States Department of Agriculture (USDA) Regional Food Business Center (RFBC)

In May 2023, the USDA Regional Food Business Center (RFBC) was established nationwide to promote economic opportunities and build a more diverse and resilient food system. As part of the RFBC initiative, the North Central Food Business Center (NCFBC) was formed to serve Minnesota, North Dakota, and South Dakota, receiving a grant of \$15 million over five years. The Southwest Regional Development Commission (SRDC) offers technical support across our nine-county region. Over the past year, the SRDC connected numerous grocery stores and/or meat processing facilities to grant opportunities including the RFBC Business Builder Subaward Grant. As a direct result of our efforts, one grocery store was able to enhance their heating and cooling system, and install night shades over their open refrigeration units and one meat locker was able to make roof insulation improvements to meet minimum licensing standards as a result of PACE loans. The SRDC is dedicated to nurturing relationships and fostering food systems growth and development in Southwest Minnesota.

## Food System in SW Minnesota

The Southwest Regional Development Commission, in collaboration with Regions 6W and 6E, was recently awarded the Minnesota Department of Ag (MDA) Meat Processing Train and Retain Grant for \$250,000. The SW MN Meat Processor Workforce Development Initiative kicked off in July and aims to assist small to medium-sized meat and poultry processors by providing training, supportive services, and tailored career navigation. The initiative will invest in 30 individuals, addressing training gaps and offering retention strategies to support careers in the meat or poultry industry.

#### **Strategic Planning**

SRDC Staff has been busy over the last few months helping to craft strategic plans for the City of Hills, Lyon and Murray County along with Southwest Health and Human Services. The SRDC helps develop individual approaches for a variety of entities. We partner with local leaders, regional stakeholders, and community members to craft tailored strategies to address specific goals.

### **RLF Site Visits**

Staff scheduled several site visits. These visits are required every three years; however, they are done more often as the need arises. ### **EECBG Grants**

The SRDC is working to help cities and counties under 15,000 population with Energy Efficiency and Conservation Block Grant (EECBG) projects. Maximum grant for eligible communities is \$20,000.

### Solid Waste Regional Plan

All counties in Minnesota must submit a solid waste plan to receive SCORE funds and apply for additional grants from the MPCA. Doing this as a 12-county Joint Powers Agreement decreases individual county costs, helps pull together resources, and arrange materials exchange for counties in the Southwest Minnesota Solid Waste Commission
